ORDINANCES, ELECTIONS AND LEGISLATIVE MATTERS

- Insert the following as proposed into Chapter 20 Departmental Revolving Fund of the Revised Ordinances of the City of Attleboro: Chapter 20 Departmental Revolving Fund Ordinance G.L. c. 44 Section 53E1/2.
- Repeal Attleboro's Special Act - An Act Increasing the Expenditure Limit on Revolving Funds in the City of Attleboro.
- For further study and recommendation: To add the phrase "Ride Sharing Services (including Lyft and Uber)" where appropriate to Sections 9-11 and 9-12 of the Revised Ordinances of the City of Attleboro to definition of Hackney Carriage. Furthermore to review those sections are written to ensure the appropriate inclusion of Ride Sharing Services such as Lyft and Uber so those services may be safely provided to the residents of the City of Attleboro. (01/17/17 NB: Mr. DiLisio)
- To the appropriate Committee for further study and recommendation: That Section 5-1.2 of the Revised Ordinances of the City of Attleboro, Powers and Duties (Amended 4/3/08), be amended by deleting that section in its entirety and replacing it with the following: The Board of Assessors shall assess taxes and estimate the value of property for the purpose of taxation. The Board of Assessors shall have all the powers and duties now or from time to time vested by General Law or Special Act in Board of Assessors. The Chief Assessor under the administrative direction of the Mayor, not to include assessing of property, shall be the administrative head of the Assessors' Department and shall assist the Board of Assessors in estimating the value of real and personal estate and in the performances of such other duties as the Assessors require. 10-3.3 Temporary Parking Rules
 - a. The Police Chief is hereby authorized by the Municipal Council to prohibit, temporarily, parking on any street or highway or part thereof in an impending or existing emergency, or for a lawful assemblage, demonstration, or procession or where public convenience requires it, provided there is reasonable justification for such prohibition. Vehicles parked in places where parking is prohibited temporarily may be moved by or under the direction of an officer.
 - b. The Police Chief is hereby authorized by the Municipal Council to temporarily waive parking restrictions or prohibitions on any street or highway or part thereof for good cause shown, at the request of the Mayor or an owner of property on such street or highway, provided that such waiver does not impair public safety or convenience. *(Also referred to TSC)* **(PH held and closed 12/06/16)**
- That this Honorable Body work in conjunction with the Traffic Study Commission, the Police Chief, the Superintendent of Schools, the DPW Director, the Principal of Willett Elementary School, and residents of the neighborhood to address the well-documented traffic concerns in and around Willett Elementary School, including (but not limited to) the speed limit and creating a safe environment for pick-up and drop-off of students in this area. *(Also referred to TSC)*

- That this Municipal Council create a City policy stating that Water and Wastewater Departments (Water and Wastewater Enterprise Accounts) will not charge the City of Attleboro school system for services provided and/or That this Municipal Council make a temporary policy change to not charge the Attleboro School Department for Water and Wastewater Usage Costs in 2017; with the possibility of doing so again in 2018 if the Water and Wastewater Enterprise Account show retained earnings. - To research/investigate establishing a separate Stabilization Fund for the purposes of establishing a fund to replace the Attleboro High School track surface and/or the artificial athletic field in the future. (NB—Mr. Kirby and Mr. Conti)
- To establish a procedure for notifying the business community of proposed new ordinances or revisions to existing ordinances that may impact their businesses. (New Business—Mr. Cook and Mr. Bergevine)
- That an ordinance be established requiring that all fees enacted by the city be reviewed on a bi-annual basis.
- Create and implement beginning in FY06, a Debt Policy.

Anyone wishing to hunt in Attleboro should get his/her license - in Attleboro - possibly at the City Clerk's Office or Police Department. Attleboro's laws should be given with the license and the applicant should sign an acceptance of the rules of our city. If the state has taken over the handing out of hunting licenses, then the hunter should still have to visit the City Clerk's Office or the Police Department to obtain the hunting laws of Attleboro.
As the only legal place too hunt in Attleboro is on private property - with permission - any land owner that is going to allow hunting on their property, should have to notify/register with the APD.
