LICENSING BOARD MINUTES January 21, 2021 6:00 p.m. (Remote Meeting)

Licensing Board Members Present: Chairman Dave Wood and Tom Dion

Request from Mediterranean Grill & Pizzeria LLC d/b/a Mediterranean Grill & Pizzeria, 595 Washington Street, for a change of manager to Sally Lajoie

Dave Wood asked Sally Lajoie about her experience.

Ms. Lajoie explained that she has owned the ETC Lounge for 12-1/2 years and also worked as a law assistant. She mentioned she is an LLC Manager for the Mediterranean Grill.

Dave Wood explained sting operations and Tom Dion asked if there was a specific age that staff was trained to ask for identification.

Ms. Lajoie answered that all staff is TIP certified and she has CPR and Allergen certifications.

Dorotheos Chatziioannou said he has been and LLC Member for the last 1-1/2 years.

Voted on Roll Call (2 yeas), to approve the request from Mediterranean Grill & Pizzeria LLC d/b/a Mediterranean Grill & Pizzeria, 595 Washington Street, for a change of manager to Sally Lajoie.

Request from Fei and Ling Restaurant d/b/a Hong Kong Treasures, 28 County Street, for a change of manager to Yong Jiang Huang

Owner Fei Pan explained that Yong Jiang Huang (John) has been working at Hong Kong Treasures for over 10 years. He has gradually taken over the manager role over the years and now handles everything.

Mr. Wood asked if John had other experience.

John said he worked as a server at another restaurant. He said this is the first time he is responsible for a liquor license.

Mr. Wood explained the importance of not over-serving liquor and not serving to minors.

John said he has had a lot of restaurant experience and he and the staff are TIP certified.

Mr. Wood asked what the carding policy is.

John answered 40 and under.

Mr. Dion mentioned that Hong Kong Treasures failed a police sting in the past.

John said he learned from that violation and has not had any since.

Voted on Roll Call (2 Yeas), to approve the request from Fei and Ling Restaurant d/b/a Hong Kong Treasures, 28 County Street, for a change of manager to Yong Jiang Huang.

Board members discussed that police sting operations have not happened in some time. An inquiry will be made to Chief Heagney if a compliance check could be scheduled.
