Request from Mass Audubon - Oak Knoll Wildlife Sanctuary, 1417 Park Street, for a One Day License to serve beer/wine on June 8, 2019 from 6:00pm – 10:00pm for their “Night at the Knoll” fundraising event

Speaking in favor of the application was Lauren Gordon, Director of Oak Knoll Wildlife Sanctuary. She stated that they have held the “Night at the Knoll” fundraising event for several years. Ms. Gordon said that in the past, the caterer had a license to serve. Since they have hired a different caterer, she was unaware that a One Day License was needed. She explained that for this year’s event, Extra Hands was supplying a licensed bartender and that attendees would be 21 years of age or older. Ms. Gordon explained that the liquor was being donated by an approved wholesaler.
