Wastewater Project Update:

Tom Hayes, Wastewater Superintendent provided project update:

Gravity Thickener #1 & #2 (Contractor-IPC Lydon)-gear drive on order 10-12 week lead time for parts. Project on hold until parts arrive.

Lime Silo Boot-(Contractor-IPC Lydon) on hold until COVID 19 pandemic subsides. Variable Frequency Drive (VFD) (Contractor-Fall River Electric)- project on time, 2 VFD's installed a week 6-7 weeks remain to completion.

Brennan Middle Wamsutta Middle School Roof Repair Project

Susan Gleason, Skanska reviewed April 24, 2020 kick off meeting notes. Russo Barr working on construction design documents. Anticipate advertising bid late May using online platform for bid submission. Anticipate completion in August 2020.

Attleboro Public Library Building Envelope Repair Project

Evan Warner, STV DPM provided a project update. BH+A continues to work with mechanical engineer to confirm existing conditions. It was determined the library needs remain open during the project therefore the project team is developing a phased approach to the project. Design Development completed end of May with estimates Construction Documents to be completed end of July, project out to bid month of August and securing GC early to mid-September. It was determined CH 149 standard design bid build is the best option for the project. Deborah Robinson, BH+A two main components of project exterior- solve air and moisture filtration issues, windows leaking and roof issues. Interior full replacement of HVAC systems. Phased approach Phase I includes contractor mobilization, roof repair. Phase II- Mechanical take areas in phases. Closing down only areas work is being performed. Project duration anticipated to be 10 months commencing in Fall 2020 and concluding early Summer 2021. Library Trustee, Charlie Oliver-Question relating to upgrades to elevator. City Auditor to determine if elevator upgrade falls within the guidelines of the bond authorization.
