Brennan Middle & Wamsutta Middle School Roof Repair Project:

Presentation was made by Andy Barr and Dale Caldwell. They recommended that the City accept the bid of MDM Engineering Company, Inc. in the amount of \$2,486,000.00. This is approximately \$700,000.00 under the construction budget amount. Russo Barr has extensive positive experience with MDM. It was moved, seconded, and unanimously voted to recommend to the Mayor that the City execute a contract in the amount of \$2,486,000.00 with MDM Engineering Company, Inc.
