

Dear Ms. Drain:

I found two discrepancies while preparing the Campaign Finance Form for Kimberly Allard. These mistakes were traced back to addition errors in the report ending 10/29/2007 and 12/31/2007. Because of a mathematical error, I did not include \$400 (\$300 loan to the campaign from Ms. Allard and \$100 of fundraising) in receipts for the 10/29/2007 report and over reported the expenditures of the 12/31/2007 report by \$252.00. With these errors carried forward, the correct balance for the report ending 12/31/2011 should be \$15.39.
