## Library Repair Project

Project Update

21% through construction and on schedule. Evan Warner shared photos of the progress. Balconies are stripped and in the metal shop for repair. Once extent is known we will revisit allowances. Roof repair continues. Air and vapor barriers installed and most of the membrane roofing is in. Slate roof has been delivered. Copper work mark-up is finished and awaiting review. Damaged wood below slate roof replacement is in the change log. Some savings on membrane roofing will offset this new cost.

## Window Discussion

Goal is to keep all of the added window work within the existing schedule. There are roughly 35 windows which is all in the 1993 addition and some ground level windows in 1907 building which were not included in the scope but are deteriorated to the point that replacement is necessary. Replace wood with aluminum cladding with the same materials, but with far better window technology and a 20 year warranty. Recommending Anderson windows as the standard color would match and we avoid paying a custom color fee from Marvin.
